Local attorneys to receive Pro Bono Awards

The Savannah Bar Association (SBA), in partnership with Georgia Legal Services Program (GLSP), announces the 2020 winners of the Pro Bono Awards. The Pro Bono Awards honor attorneys who take on legal matters without the expectation of getting paid. Attorneys provide service without charge as a way to give back to their communities and to meet their ethical obligations as attorneys.

The awards were presented at the monthly meeting of the Savannah Bar on April 22.

Joey Turner received the Pro Bono Champion Award for handling the highest number of legal cases in a single year. Turner specializes in criminal defense and has been representing clients throughout southern Georgia for more than a decade.

Stephen Harris received the Pro Bono Advocate Award for providing exceptional services to the underserved in the Savannah area. Harris has been in general practice in Savannah for 50 years. He is a long-time GLSP volunteer and tries to have an open file on a pro bono case most of the time.

Bouhan Falligant LLP received the Pro Bono Catalyst Award for promoting the mission of GLSP. Bouhan Falligant is a Savannah law firm that handles a broad range of complex legal issues. The firm has a long history of supporting programs and projects that benefit the well-being of the local community.

Jon Maire received the Pro Bono Service Award for his many years of service as an in-house volunteer attorney. Maire practiced law in Michigan before retiring to Savannah. He has volunteered with GLSP for nearly 20 years and has assisted over 350 GLSP clients during that time.

GLSP's 10 regional offices are located in Albany, Athens, Atlanta, Augusta, Brunswick, Columbus, Dalton, Gainesville, Macon and Savannah. GLSP partners with local bar associations in each city. Pilot Project Creates New Children's Attorney Office In Chatham County Juvenile Court - Attorneys and Staff Needed

A new Children's Attorney Office is being established in the Chatham County Juvenile Court as a part of a pilot project to improve representation of children in dependency cases. The Georgia Office of the Child Advocate (OCA), the Supreme Court Committee on Justice for Children (J4C), the Division of Family and Children Services (DFCS), Chatham County Commission and the Chatham County Juvenile Court are all engaged in this pilot project.

With the support of Chairman Ellis, the County Commissioners, and the County Manager, the project establishes a new Children's Attorney Office. It will provide three dedicated, full-time children's attorneys, one for each of the three Juvenile Court courtrooms, as well as an office social worker and support staff. While the court is fortunate to have dedicated panel attorneys representing children and parents in dependency cases, there are too few attorneys on the court's panel, the case load is high, scheduling is very challenging, administrative support is lacking for many attorneys, and the cases are frequently complex. The project will provide the three full-time attorneys with ongoing training, support, fewer scheduling conflicts, and the ability to dedicate more time to each case. This, in turn, will allow the new office members to dedicate their careers to, and develop greater expertise in, child representation. The program will also provide additional training and technical assistance to all dependency panel attorneys in this court.

Presiding Judge Thomas L. Cole, Judge Roxanne E. Formey, and Judge Lindretta Grindle Kramer are confident that this program will improve outcomes for the children and families appearing before this court and strongly encourage all interested attorneys to apply for positions with this office.

The hiring process for the new attorneys and staff will be conducted through Chatham County Human Resources with the openings being posted in May.



Panel Attorneys Needed For Juvenile Court

Chatham County Juvenile Court utilizes a panel of attorneys from which to appoint and provide representation for parties appearing in Juvenile Court. The Court is fortunate to have a panel of attorneys dedicated to the deeply meaningful work accomplished at Juvenile Court. However, there are currently too few attorneys on this panel for the high number of cases before the Court. As a result, there are sometimes struggles to find attorneys to represent all children and parents, as well as to serve as Guardians ad litem.



Panel attorneys can choose to limit their service to only those roles of interest. These attorney panels include the delinquency and CHINS panel, dependency panel, special proceedings panel, or Guardians ad litem panel. Delinquency cases are those that would be a crime if committed by an adult. The Public Defender's office represents most children in those cases, however, conflicts require appointment of a panel attorney. Dependency cases involve the representation of a child or parent in which there are allegations of neglect and/or abuse. Special Proceedings include Superior Court transfers of custody and support matters, Probate Court transfers of temporary guardianship issues, and a variety of other matters. Guardians ad litem can be assigned in any type of case.

The case assignment process begins with an e-mail notice and a representation request to all attorneys on a specific panel. The assignment of the case is then made only to one of those attorneys that responds as willing to accept the case. The timelines in juvenile court are very short and very strict, so cases move quickly. Practice in this court is an opportunity to have a profound impact upon a child and the future course of his or her life.

Harris Lowry Manton LLP Honors Legacy of U.S. Congressman and Civil Rights Leader John Lewis with Portrait Unveiling, Donation to John and Lillian Miles Lewis Foundation

Harris Lowry Manton LLP, an award-winning, full-service trial law firm with offices in Atlanta and Savannah, recently unveiled a commissioned portrait of the late U.S. Congressman and Civil Rights leader John Lewis, which hangs in the firm's Brookhaven, Ga. office in honor of Lewis's landmark pursuit of equality and uncompromising commitment to justice.

At a special unveiling ceremony on April 2, Harris Lowry Manton LLP founding partners Jeff Harris, Steve Lowry and Jed Manton also presented a \$5,000 donation to the John and Lillian Miles Lewis Foundation, a nonprofit organization created to continue the legacy of Congressman Lewis and his wife Lillian Miles Lewis. Foundation Treasurer Mignon Morman Willis and her husband, Bill – longtime friends of John and Lillian Lewis – accepted the donation on behalf of the Foundation.

"There is no greater role model for initiating positive change and leveraging the power of the U.S. Constitution, the legal process and American democracy than Congressman John Lewis," said Harris Lowry Manton LLP founding partner Jeff Harris. "His impact on the Civil Rights Movement and groundbreaking legislative work continues to guide the pursuit of justice for our clients and our community."

The commissioned portrait of John Lewis is the work of acclaimed Atlanta-based artist Patrick Lewis, who is known for his expressive, loose paintings of historic figures and iconic brands. The artist utilizes unstructured,



dramatic brushstrokes and a commanding mix of colors to depict Congressman Lewis in the foreground with the Atlanta skyline behind him. The acrylic and mixed media painting, which measures 6x8-feet, features one of the Congressman's most noteworthy quotes in the bottom left corner: "Never, ever be afraid to make some noise and get in good trouble, necessary trouble."

"This one-of-a-kind portrait of Congressman Lewis occupies a place of honor and distinction at our firm's Brookhaven office," said Harris Lowry Manton LLP founding partner Jed Manton. "I believe this painting will offer daily inspiration to our attorneys and staff, encouraging them to honor his legacy through their work advocating on behalf of our clients."

An Alabama native known for his courage and nonviolent approach to initiating change, Lewis was arrested 40 times during the Civil Rights Movement. He integrated the bus system as a Freedom Rider, delivered a speech at the historic March on Washington and, most notably, led 600 peaceful protestors supporting voting rights across the Edmund Pettus Bridge in Selma, Alabama in 1965.

As Director of the Voter Education Project, Lewis registered nearly four million minority voters and was later appointed by President Jimmy Carter to head the federal volunteer agency ACTION. In 1981, Lewis was elected to Atlanta City Council, and in 1986, he began 33 years of service as a U.S. Congressman. Widely considered "the conscience of the U.S. Congress," Lewis was presented with the Medal of Freedom by President Barack Obama for his numerous civic contributions to the nation, including establishing the Dr. Martin Luther King Jr. National Historic Park in Atlanta, leading the Emmett Till Unsolved Civil Rights Crime Act and helping found the Smithsonian's National Museum of African American History and Culture in Washington, D.C. Lewis dedicated his life to protecting human rights, securing civil liberties and building what he called "the Beloved Community" in America. Lewis died on July 17, 2020 at age 80.

Founded in 2017, the John and Lillian Miles Lewis Foundation is a 501(c)3 nonprofit organization continuing the Congressman and his wife's lifelong work by encouraging and supporting individuals, groups and organizations to reach for the greatness in themselves.

2021 New Superior Court Domestic Relations Cases ADR Screening Process and Tools

Starting on January 1, 2021, a revised ADR Screening process is required by the Georgia Commission on Dispute Resolution ("GCDR"). The revised screening process is designed to help better identify domestic violence ("DV") cases, determine whether mediation can be conducted safely and free of coercion, and ensure that a specialized domestic violence mediator is assigned to the case when necessary.

The revised ADR Screening process for Chatham County and how it interacts with The Mediation Center ("TMC") is as follows:

- 1) TPO Registry Check Chatham County ADR office is required to check every Superior Court contested domestic relations case in the TPO registry before referring the case to mediation. <u>If there are results in the TPO registry</u>, we proceed to Tier II screening.
- 2) Tier I Screening All <u>clients/citizens</u> must complete Tier I screening prior to mediation. Tier I screening is conducted using an online questionnaire: https://godr.org/adr-screening/. This online questionnaire is in lieu of the hard copy Domestic Relations screening form that was used prior to January 1, 2021.
 - a) Attorneys send the link to their clients for completion.
 - b) Link to the online GODR screening tool: https://godr.org/adr-screening/
 - Also located on the Attorneys Tab on our website:
 - https://mediationsavannah.com/mediation/information-for-attorneys/
 - c) Once a citizen has completed the questionnaire, the questionnaire responses are automatically routed to the Chatham County ADR Office (or appropriate ADR office for other county cases) for review. TMC will receive a client's screening form approximately two business days after the form was completed. Questionnaire responses are not sent to the party, attorney, or others due to safety issues.
 - d) If indicators of domestic violence in Tier I proceed to Tier II screening
- 3) Tier II Screening: Key question in Tier II Screening: Can this mediation be done safely and free of coercion? Does the party being screened currently possess the capacity to advocate for their own interests during mediation (has the violence prevented them from being in a mind-frame conducive to mediation)?
 - a) ADR staff or the mediator are the persons authorized to do the Tier II screening with the citizen. The link to the Tier I screening has been modified wherein it will not automatically go to Tier II if triggered by the answers to the Tier I questions.
 - b) The ADR staff or the mediator will explain the mediation process and the safeguards.

Other Domestic Relations ADR Rules:

- Mediation can not start until the Tier I screening is completed & received by TMC.
- If no Tier I has been received <u>before mediation = Automatically the case is mediated with Domestic Violence protocol in place until it is fully screened.</u>



- If a case is labeled Domestic Violence:
 - ➤ the mediator MUST be a trained Specialized Domestic Violence mediator (this is an additional 14 hour training to be certified)
 - > mediation must be done in a secure location:
 - Virtual and in separate break-out rooms for duration of mediation
 - At a secure location, such as the Courthouse, with proper security (officers, metal detectors) and in different rooms the entire time and neither know the location of the other.
 - A case labeled as Domestic Violence cannot be mediated at TMC offices (even if only 1 person wants to be at TMC) because there is no metal detector or security officers.

TMC ADR Process to ensure screening compliance:

- One week before mediation:
 - TMC will review the case file to ensure parties have completed the online screening form
 - ▶ If the screening form is in the file, and there are no concerns, no further screening is required.
 - ▶ If TMC has not received the Tier I screening form then TMC will contact the party or party's attorney to perform Tier I screening.
- One week before mediation: TMC will email the parties the following information:

ATTORNEYS: Please complete the required in a timely manner. Failure to complete said forms will delay the start time of the mediation which impacts all persons involved in said mediation.
