2021 SBA Scholoarships Available

The Savannah Bar Association undertakes to award scholarships to deserving students each year. The 2021 guidelines for the scholarships are as follows:

Judge Eugene H. Gadsden Scholarship:

The Judge Eugene H. Gadsden Memorial Scholarship was established by the Savannah Bar Association in tribute to the memory and legacy of Judge Gadsden as an outstanding community leader known for his character, integrity, and compassion. His fairness, patience, and wisdom served as an inspiration not only to all lawyers and judges but also the community at large. The purpose of the scholarship is to assist a graduating senior from a high school in Savannah in attending an accredited college or university. The award is based on merit, and it provides an annual amount of \$1,000 for four years. The award may be used for tuition and fees, books, and other academic expenses. All applicants who have applied for or will be receiving other financial support must reveal that information and include it with the application. Applicants must meet entrance requirements of the institution and maintain grades in keeping with the standards of the Hope Scholarship. *Applications for the Judge Eugene H. Gadsden Scholarship must be obtained from the high school's guidance counselor*.

Judge Phyllis Kravitch Scholarship:

The Judge Phyllis Kravitch Scholarship was established by the Savannah Bar Association in tribute to this outstanding community leader known for her character, integrity, and compassion. The fairness, patience, and wisdom of Judge Kravitch served as an inspiration not only to all lawyers and judges but also the community at large. The purpose of this scholarship is to assist a rising second or third-year law school student from Chatham County in continuing his/her education at an accredited school of law. The scholarship award of \$2,500 is given to one student based on merit for the second or third year of study in law school. A second-year law student who receives an award may apply for an additional award for his/her third year. The award granted may be used for tuition and fees, books, and other academic expenses. All applicants who have applied for or will be receiving other financial support must reveal that information with the application. Pro Bono Publico – "for the public good" – We all know the good that pro bono work is: representation for those who could otherwise not afford an attorney, better resolutions for low-income clients, improving the flow of court cases, feeling good knowing that you helped someone out, and builds a more just society.

There are other lesser-known benefits from pro bono, both professional and personal. Instead of focusing on the benefits of pro bono work to the clients, lets look at the benefits to the pro bono attorney.

There is much to be gained professionally from doing pro bono work. Pro bono cases allow attorneys to sharpen their litigation skills. A new attorney will have direct contact with a client, perfect interview skills, learn how to speak in plain English to clients, and learn how to manage client expectations. A new attorney can gain experience investigating facts, taking depositions, interviewing witnesses, and reviewing exhibits that may end up in evidence. A new attorney can also gain trial skills through pro bono, getting the opportunity to appear before a variety of judges in a variety of cases. The skills will build an attorney's confidence as he or she gets more comfortable with client-case management.

Experienced attorneys can brush up on legal skills. A transactional attorney can go to court to advocate for a tenant or a TPO petitioner. A litigator can take a case that can be completed in the office, such as advice and counsel on a housing issue or drafting a will. Attorneys can also learn a new area of the law through pro bono work. GLSP offers online resources, trainings, and assistance from experienced staff attorneys to support pro bono attorneys in areas in which they don't regularly practice. Pro bono work also allows attorneys networking opportunities, building business contacts, and becoming better known to the judges before whom they appear. It also helps to build an attorney's reputation in the legal community. Networking and reputation may open doors both professionally and personally as people learn about your commitment to help those in need. POSITION OVERVIEW:

The Pro Se Clerk provides direct assistance and support to the magistrate judge, in chambers, regarding substantive legal and procedural review of cases pending before him, predominantly prisoner civil litigation, including state and federal habeas corpus petitions and civil rights complaints, social security disability appeals, non-dispositive civil motions, and pretrial criminal motions. Within the scope of the cases assigned, the Pro Se Clerk's primary responsibility will be to review complaints, petitions, motions, and pleadings to identify and analyze the issues and basis for relief; perform legal research; and draft appropriate recommendations and orders. This position is a two-year term-limited position. Although the position is term-limited, the position is not subject to, and shall not be credited against, the four-year limitation on federal term law clerk appointments. Although applications from graduating third-year students are accepted for this position, the anticipated start date necessitates that preference will be given to applicants who do not anticipate, or are willing to forego, sitting for a state bar exam in the Summer of 2021.
