SBA Holds Annual Law Day Luncheon

On Thursday, May 17, the Savannah Bar Association held its annual Law Day Luncheon at the Savannah Golf Club. Law Day is a day to recognize our nation's commitment to the rule of law. This year marks the 60th Anniversary of Law Day. The theme for this year was "Separation of Powers: Framework for Freedom," which allowed us to reflect on the separation of powers as fundamental to our constitutional purpose and to consider how our governmental system is working for ourselves and our posterity. The Savannah Bar Association has two components to its Law Day observance. First, the YLD sends its members into local classrooms to engage in discussions about the Law Day theme. Over the last several weeks, members of the YLD spoke to classes at Savannah High School, Windsor Forest High School, and Islands High School. The second component of the Savannah Bar's observance of Law Day is the presentation of four awards: the Judge Edward Hester Award, the Liberty Bell Award, the John B. Miller Award, and the Robbie Robinson Award.

The Judge Edward Hester Award recognizes outstanding local courthouse personnel who have been of particular assistance to the members of the local bar. Judge Coolidge presented the 2018 Judge Edward Hester Award to State Court Clerk of Court and Court Administrator Brian K. Hart.

The Liberty Bell Award recognizes a member of the community for outstanding service in promoting a better understanding of our Constitution and Bill of Rights. The recipient encourages a greater respect for law in the courts, stimulates a deeper sense of individual responsibility so that citizens recognize their duties as well as their rights, and fosters a better understanding and appreciation of the rule of law. Lester Johnson presented the 2018 Liberty Bell Award to Ernest W. Lee, a former lawyer who now teaches social studies and government classes at Windsor Forest High School.

The John B. Miller Award recognizes a member of the Savannah Bar who is selflessly dedicated to making the Savannah area a better place to live through volunteer community service. Richard Sanders presented the 2018 John B. Miller Award to SBA member Doug Andrews.

The Robbie Robinson Award recognizes a member of the legal profession who has demonstrated dedication to the principles of service to individuals and of advancement of the legal, political, social and civil rights of the Savannah community. Bill Broker presented the 2018 Robbie Robinson Award to Robert Bush, an attorney with Georgia Legal Services

2018 Legal Food Frenzy in Coastal Georgia

On May 18th Attorney General Christopher Carr announced that law firms and legal organizations across Georgia raised a record breaking \$400,325 and collected 18,809 lbs of canned goods during the 7th Annual Georgia Legal Food Frenzy(LFF). The LFF was a two-week, statewide food and fund drive competition that was held among Georgia's lawyers to combat hunger across the state.

From April 16 - 27, over 235 law firms and legal organizations representing more than 17,000 members of the legal community went head – to – head to raise food and funds for their regional food bank. The legal community of the Coastal Georgia region had 23 participates who were able to collect 1,983 lbs of food and \$12,657.88 in funds. With each \$1 donated, Second Harvest can provide 5 meals to those in need.

1 in 4 children in Georgia are at risk for hunger and over 60% of them are eligible for free or reduced lunches during the school year, but when they are home for the summer their families often struggle to put enough food on the table. The Legal Food Frenzy is perfectly timed to help food banks meet this increased demand and ensure that kids in Georgia won't worry about when their next meal is coming.

During the final days of the competition, Attorney General Carr issued a challenge to individuals and firms to donate the equivalent of one billable hour during the competition by saying, "As the phrase goes, time is money... What better way to dedicate our time than to fighting hunger?" Many responded to his call, with over 120 individuals and companies personally donating 500 dollars. The six VIPs in the Coastal Georgia region were: Bronze VIP (\$1,000+) The Eichholz Law Firm; Copper VIP (\$500+) Thomas Cullen, Hunter Maclean; Edenfield, Cox, Bruce & Edenfield, The Dunn Foundation, Hunter Maclean; Jonathan Pannell, Gray Pannell & Woodward; and The Pedigo Law Firm, P.C.

Within the Savannah and Coastal Georgia Region the winner of the Regional Points Per Person was The Pedigo Law Firm, P.C. with 1,437.5 points and the Regional Total Points Winner was Hunter Maclean with 25,181 points. Additional participants include:
